

Adsterra ADSTERROIDS New Year 2025 Promo

Official Rules

This Agreement governs your participation in the Adsterra ADSTERROIDS New Year 2025 (the "Promo") described herein.

This Agreement constitutes an integral part of Adsterra Terms and Conditions (the "Terms and Conditions"), which you agreed upon when creating an Account with Adsterra ('Account'). Areas and/or terms not covered by this Agreement are regulated by the provisions of Adsterra Terms and Conditions.

This Agreement is entered into and between:

Adsterra, including its affiliated and subsidiary companies, being the organiser, creator, and owner of this Promo; and You (the "You", "Yours", etc.), a client of Adsterra (Advertiser / Publisher) and therefore the holder of an Account, hereinafter collectively referred to as the "Parties", "Partners", "Advertisers", "Publishers", and separately as "Party", "Partner", "Advertiser", "Publisher", etc. The Parties act as independent contractors.

Whereas Adsterra celebrates 2025 New Year and wishes to offer prizes to lucky Partners through the Promo;
and Whereas you seek to participate in the Promo and take the chance to win a prize,
Now you and Adsterra hereby agree as follows:

BY CLICKING "OK" BUTTON ON THE LANDING FORM OF APPLICATION, YOU (A) CONFIRM THAT YOU ARE AWARE AND COMPLY WITH PRESENT AGREEMENT AND AGREE TO BE BOUND BY IT AND OUR PRIVACY POLICY PUBLISHED AT THE WEBSITE; (B) ACKNOWLEDGE AND AGREE THAT YOU HAVE INDEPENDENTLY EVALUATED THE DESIRABILITY OF PARTICIPATING IN THE PROMO AND ARE NOT RELYING ON ANY REPRESENTATION, GUARANTEE, OR STATEMENT OTHER THAN AS EXPRESSLY SET FORTH IN THIS AGREEMENT; (C) HEREBY REPRESENT AND WARRANT THAT YOU ARE FULLY AUTHORIZED SIGNATORY AND HAVE FULL LEGAL CAPACITY AND AUTHORITY TO ENTER INTO THIS AGREEMENT AND THAT YOU ARE AND WILL REMAIN IN COMPLIANCE WITH ADSTERRA TERMS AND CONDITIONS AND THIS AGREEMENT AND THAT YOU SATISFY ALL PARTNER'S CONDITIONS AND REQUIREMENTS PROVIDED IN THIS AGREEMENT; (D) AGREE TO RECEIVE DIRECTLY TO YOUR EMAIL NEWSLETTERS, TRAFFIC MONETIZATION INSIGHTS, LATEST PROMOTIONS, CASE STUDIES AND TUTORIALS FROM US.

Participation in the Promo

To take part in the promos and have the right to get one or more of the claimed prizes, each Partner has to fulfill the following conditions.

Promo Dates

Official dates:

- Event period: December 1st-31st 2025
- Frontier Scout Prize Draw: January 17th 2026
- Main prizes draw: January 23rd-30th 2026
- Bonuses will be added to the winners' accounts: No later than February 10th 2026

The Main Promo

To apply for your participation in the Main Promo you must have an Advertiser / Publisher Account with Adsterra or register online until the Promo's end date (the "Registration Period"): Dec 31st 2025 for the Main Prize Draw.

For your registration to be accepted and in order to enable your participation in the Main Promo, you must have registered only once for each role (Advertiser / Publisher) and by using one (1) email only.

If you're an Advertiser:

- Leave and enter your Adsterra Advertiser Account email in the required field on the Landing page dedicated to the Adsterroids Online Promo ([link])
- Play the offered game using your skills

As an Advertiser, you may get extra chances for winning in the draw according to the rules below:

- Spend \$100+ using your Adsterra Advertiser Account (obligatorily the one for the email you claim for the draw) in December = 1x chance
- Spend \$500+ using your Adsterra Advertiser Account (obligatorily the one for the email you claim for the draw) in December = 2x chance
- Spend \$1,000+ using your Adsterra Advertiser Account (obligatorily the one for the email you claim for the draw) in December = 3x chance

If you're a Publisher:

- Leave and enter your Publisher Adsterra Account email in the required field on the Landing page dedicated to the Adsterroids Online Promo ([link])
- Play the offered game using your skills

As a Publisher, you may get extra chances for winning in the draw according to the rules below:

- Earn \$50+ using your Adsterra Publisher Account (obligatorily the one for the email you claim for the draw) in December = 1x chance
- Earn \$250++ using your Adsterra Publisher Account (obligatorily the one for the email you claim for the draw) in December = 2x chance

- Earn \$500+ using your Adsterra Publisher Account (obligatorily the one for the email you claim for the draw) in December = 3x chance

Main Draw Prize Fund

The player with the highest playing score for the whole Promo period will get a guaranteed prize of \$100 regardless if they're Advertiser or Publisher. Other prizes are to be drawn randomly due to the following scheme.

Prizes available for accepted / qualified Advertisers include:

- 350 merch points (3 prizes)
- \$500 (1 prize)
- \$200 (3 prizes).

Prizes available for accepted / qualified Publishers include:

- 350 merch points (3 prizes)
- \$300 (1 prize)
- \$150 (2 prizes)
- \$100 (3 prizes).

Winners will be determined randomly with a randomizing online tool no later than January 30th 2026 and announced on Adsterra's social media. The exact date of the draw will take place between Jan 23rd and Jan 30th and will be announced on Adsterra's social media. The winners will get their prizes no later than February 10th 2026.

The Frontier Scout Prize Draw

To enter this draw the participants don't have to own an Adsterra Account.

Each participant has to:

- Post on social media (Facebook, Linkedin, Instagram, X, etc.) with #Adsterroids hashtag before December 15th
- Keep their post visible and their profile public

1 random winner will be determined randomly with a randomizing online tool and announced on December 17th 2025 on Adsterra's social media. The winner will get \$200 transferred directly to them via their preferred payment method no later than February 10th 2026.
